Ongoing draining projects to support the development over the last 5-10 years to improve detention/retention:

- W170 Briar Branch channel updates to reduce the flood risk almost complete, added box culverts
- Extension of Memorial Drive from Beltway east 55% complete, working to speed up the progress to minimize the use of a temporary turn lane, TXDOT approved the Memorial project from Tallowood to Gessner
- Discussion of widening and deepening the ditch along Bennigus at Memorial
 Localized detention pond likely required in the long term

2. Selection of nominating committee

The guidelines have a process for nominating directors which are superseded by state laws -

- 1. Publish prior to the election
- 2. Solicit people to run, however, any one can run for an open potion

Consequently, the nominating committee helps to potential volunteers but does not exclude anyone who wants to run.

Decision to nominate Ferrier, Deal, Rosca on the nominating committee: Marshall motioned, Strum seconded, motion passes

3. Discussion and voting regarding conclusion of pool season

Suggestion that we fine tune the maintenance budget when the pool closes for the season to also include the unexpected maintenance with the potential to increase annual maintenance dues

The labor and materials cost are difficult to predict, Dunson and Strum have some suggestions to keep the inflating costs

Consider a potential fee that goes toward a differed maintenance plan Discuss with Natalia the need for a temporary budget committee
