Security - Michael Ferrier

Captain Hutter with HCSO gave general overview of what their operations covered and response time for various calls (12 neighborhoods covered by 3 officers; response time is 7 minutes for non-emergency calls and under 5 minutes for emergency calls); one Constable on day shift and two Constables on night shift; Constable shows up if there is a threat to life when called, if anything else, call will get transferred to HPD; fielded questions regarding Flock camera systems; Fonn Villas itself has low crime, but West Houston does have high crime
