# Minutes of the Regular Meeting of the Fonn Villas Civic Association

  - Pat Clynes noted that it seems some of the entrances have not been tended to recently and need some care.

## VIII. BUSINESS

- a. Shrubbery on Attingham Fence (Pat Clynes, Ross Roberts)
  - Ross Roberts is the person on the board who is most familiar with this area, but he's not at the meeting.
  - Discussion of reducing height of shrub; can we reduce height of fence and save money?
  - Decision on this was deferred to November meeting.

- b. Increase in fee to be paid for delivering newsletter (David Robertson)
  - Discussed need to increase compensation for individuals who deliver the Fonn Villas News every month.
  - David Robertson moved: As of the October 2012 edition of the Fonn Villas News, the fee paid for delivery of the newsletter be raised to \$60 for a single sheet, or \$80 for multiple sheets. The extra \$20 for multiple sheet delivery would be paid by the organization which requested the additional sheets. The motion was seconded by John Baugher. The motion was unanimously approved.
- c. Recruitment of new Parliamentarian / Secretary (David Robertson)
  - David reported that he had recruited Melinda Speight to the position of Secretary, which would allow David to give up the role of secretary and take on the role of Parliamentarian. This would allow John Baugher to conclude his officer duties around the end of the year.
  - Melinda was in attendance at the meeting, just watching the process. If she agrees, she can be voted on at next meeting.
- d. Pool Discussion (Pat Clynes)
  - Pat reported that several residents have approached him about including Fonn Vilas Swim Club membership along with (mandatory) membership in the FVCA. This might be "grandfathered" in, allowing current residents to continue to choose whether or not to join the Swim Club. Future residents would automatically be enrolled in the club.
  - Pat and others noted that some neighborhoods in our area had already done this.
  - This discussion was simply to introduce the idea to the board. Pat will be talking to residents and Swim Club leadership to gather information. One possibility to investigate this is to appoint a task force that would gather information and report back to the Board.
  - Pat noted that the FVSC is considering new signage for the pool. They may request financial assistance from the FVCA, but no official request has so far been received.
- e. Approve list of homeowners in Fonn Villas for billing (Treasurer)
  - No action was taken. Pat Clynes will investigate who has this list. The past treasurer and current treasurer will also check their records for this list.
- f. Approve CPA to handle billing for Maintenance Fund (Treasurer)
  - We have used Moore & Associates for this purpose for approximately 20 years.
  - · Action of this was deferred to November
- g. Approve City of Houston SNAP projects for submittal to Memorial SN 16 (Tonya Wright, Pat Clynes)
  - There was some discussion of requesting a speed hump on Barryknoll, west of Hallie.
  - No action was taken
- h. Discussion of Raising Millage Rate (Pat Clynes)
  - Pat noted that we have not raised our millage rate in many years, but that the rate we pay for Constable patrol will likely be increased this year.

• A decision on this must be made in November, and we will have a discussion in that meeting.

# IX. ADJOURN

David Robertson made a motion to adjourn the meeting. John Baugher seconded the motion. The motion was approved unanimously.

The meeting adjourned at 8:21 p.m.
