Architectural Standards Committee Report

May 6, 2013

- 1. Seven ACC applications were submitted and approved since the last monthly FVCA meeting. The approvals were one for demolition, two for new construction, two for pools, and two for home additions.
- 2. The City required a variance for the new home construction on Pinerock. It was learned that the City has an ordinance for new construction which states that the new foundation must be 20 feet from the street. The owners submitted a request for variance which was supported by the FVCA. Our deed restrictions allow for a 15 foot distance from the street. I attended the variance hear which was granted by the City Board. This requirement for a variance impacts 79 other properties here in Fonn Villas which was brought up at an ACC meeting this past month. Following a discussion it was noted that I should contact the City about obtaining a variance for the 79 properties affected by this City ordinance. Initial contact has been made and I have been referred to Ms Misty Staunton at 713-837-7837. I will follow-up to determine what must be done to obtain a variance for the 79 properties here in Fonn Villas.

3. The next inspection tour of the subdivision will occur this calendar quarter.

MEMORANDUM

May 6, 2013

To: FVCA Board of Directors

From: FVCA Task Force on Swim Club Connection

- 1. The members of the Task Force are Nete Sundt, Will Frederking, Alex Rosco, Jim Egger Karlston Nassar, Grady Randall, Jim Davidson. We are in complete agreement that the swim club is an enhancement to property values.
- 2. Meetings held: 3
- 3. Surveys of area subdivisions: 13 total
 - 3 have swim clubs with mandated memberships Wilchester, Memorial Glen, Memorial West.
 - 4 have swim clubs that are separate from their H.O.A. -- Memorial Forest, Memorial Bend, Memorial Plaza, Notingham Forest.
 - 6 do not have swim clubs.
- 4. FVSC Membership 2012. There were 161 Equity Members (120 were FV residents; 41 were not FV residents). In addition there were about 60 seasonal members.

Note: Only 34.6% of FV residents were FVSC members. Votes needed to amend FV deed restrictions: $347 \times 51\% = 177$.

- 5. FV Homes sold by realtors since 2000 (13 years): 191 sold for an average of 14.7 home per year.
- 6. The Task Force is considering six options for Mandatory Swim Club Mernbership
 - 3 are options for ALL FV lot owners to become Swim Club members.
 - 3 are options for NEW FV lot owners to become Swim Club members.
 - · No recommendations yet.
- 7. Attorney needed with experience in merging swim clubs into H.O.A. A maximum of \$1000 requested.
