February Minutes of the Regular Meeting of the Fonn Villas Civic Association

February 2014

I. CALL TO ORDER

The regular monthly meeting of the Fonn Villas Civic Association was held on February 3, 2014 at the Pines Presbyterian Church.

II. REVIEW AND APPROVAL OF MINUTES

- Minutes of the December 2013 meeting, December 16 Called Board Meeting, January 2013 Organizational Meeting, January 21 2013 Special Board Meeting, and May 13 2013 Called Board Meeting are posted on the web site.
- A motion was made by Melinda Speight to approve the minutes of the 2013 meetings listed above as posted. The motion was seconded by Will Frederking. The motion was unanimously approved.

- A motion was made by Melinda Speight to approve the minutes as posted. The motion was seconded by David Robertson. The motion was unanimously approved.

III. TREASURER'S REPORT - MAURICE STADLER

- The Treasurer's report for January was distributed before the meeting to the Board members.

- David Valerius requested discussion of the Treasurer's recommendation to transfer \$20,000
 from the checking account to the Vanguard account, which will still leave enough money in the
 checking account to cover budgeted expenses plus an additional \$13,000.
- Vanguard funds can be transferred within one to two days if needed.
- This could be handled as part of the budget discussion later in the meeting.
- The Special Events fund was discussed. Maurice suggested that we consider a constructive use for the money in this fund.

 In January, 1 new application for construction was declined, 1 new application for construction is close to being approved, and 1 new paint and reroof application was approved.

- a. Maintenance Fund Will Frederking
 - As of January 31, 25 accounts have not been paid. Letters will go out this week.
- b. Security John Moyell
 - John reported that a resident in a nearby subdivision states that at 2:55 pm sometime during the last week of January 2014, a man rang their doorbell and asked if Mr. Fargo was home. There is suspicion that if no one is at home, the man kicks in the door and burglarizes the house. The constable has been notified.
- c. Super Neighborhood Nete Sundt
 - Nete Sundt reported on the January 27 2014 meeting
 - The constable reported on the capture of the rapist in Hershey Park
 - Most of the flooding in our area occurs South of the Long Point fault that cuts diagonally through the memorial area. This could affect flood insurance rates.

 - Residents logged 12 hours in January.
- b. Directory Diane Donovan
 - · Directory has gone to the printer.

- c. Entrance Beautification Bill Prewett
 - Bill not present no report
- d. Maintenance and Parks David Valerius and Makeea Grainger
 - David has measured the broken glass globe and contacted several people to try to replace it, but he has not found a globe to replace the current one
 - Roberta Prazak offered to try to find a matching globe, when given the information from David Valerius
 - Lights and surfacing on Tennis Court dial 311 to report problems
 - David Robertson stated that the more people who call, the more attention it will get
 - Jim Egger suggested an article in the newsletter
 - Paul Dunne asked about the telephone pole that is lying in the park near the corner of Hallie and Kimberley.
- e. TIRZ 17 David Tresch
 - January meeting was cancelled last Tuesday due to weather, and has been rescheduled for Wednesday at 3:00
 - The local interactive citizens group has had 2 meetings. At the January 24 meeting, people reported that the post office on Town and Country Way will close and the land will be sold to a developer. There was discussion of Morgan trying to get a traffic study done, but the City says a traffic study is not required. A traffic study may be conducted by TIRZ and/or MetroNational.
 - The group discussed "grandfathering" of building requirements for developers that allow them to not have to add retention to projects. Citizens and HOAs were encouraged to contact the city about this issue.

- David wants feedback to take to the TIRZ about Town and Country Way being
 extended west to the Beltway feeder. The developer is asking for \$6.5 million. The
 city is asking for feedback from the citizens about the TIRZ spending this amount of
 money, plus the cost of the project. Total cost could exceed \$13 million. This land
 acquisition and project could benefit Fonn Villas in terms of traffic. Possible adverse
 effects need to be considered. TIRZ stressed that water retention and detention
 would need to be a part of this project. The city does not want to spend this much
 money and then have citizens complain that the money should have been used
 another way.
- David Valerius suggested that we will put this item on next month's agenda to see if the Board wants to take official action.

Local Interaction Group Meeting – January 24, 2014

- 1. Second meeting of this group
- 2. Turnout much larger
- 3. Reviewed items from last meeting
- 4. New business
 - a. Post Office to be sold
 - b. Traffic study may be conducted by TIRZ and/or MetroNational
- 5. The group is concerned about the "grandfathering" that exists on new development so they do not have to add any retention to their project
- 6. Urge HOAs, SNAs, and citizens contact mayor and council members about traffic and flooding concerns

Local Interaction Group Meeting - January 31, 2014

- Special meeting to gauge support for TIRZ on extending T&C Way westbound to the beltway feeder
 - a. Will take \$6.5MM to buy land
 - i. Owner currently has pulled permits to build office building
 - ii. This is \$300/sq ft
 - iii. Now would be only opportunity to get this land
 - b. TIRZ has verbal commitments with other area land owners to obtain land to make project happen.
 - Overall price would be \$125/sq ft once conveyed land is added in.
 This is close to current market price
 - c. COH is concerned residents will object to the high cash outlay to get land
 - d. Project benefits
 - i. Improved traffic flow. Gives area one more outlet
 - ii. Morgan group projects will be adding traffic
 - iii. TIRZ urged to include retention/detention in this project
