    - 1. Makeea reported via email that the dianthus flowers planted at the Old Oaks entrance last fall live year round, additional dianthus might be planted at a later time, and the spring/summer flowers will be planted soon.
    - 2. She was able to get Center Point to remove the abandoned pole along Town & Country Blvd.
    - 3. The chevron signs placed along the curve where Town & Country Blvd. and Queensbury meet is the only action the City will take to notify drivers that it is not a thru street. The City will not install barriers under any condition.
    - 4. Jim Egger reported the following from Lon Kelley:

Once again, it is time to replace the U.S. flag in the park. This has traditionally been done by Fonn Villas residents on a voluntary basis. The cost for the last flag was about \$95. Your purchase will be acknowledged in the newsletter, and may be dedicated if desired.

### VIII. BUSINESS

- A. Jim Egger provided an update on the swim club merger. The FVCA collected enough votes to approve the amendment to the restrictions. All documentation was submitted to the attorney who recorded the appropriate documentation in the County records, and the merger was finalized as of April 1, 2015.
- B. Jim met with Maurice Stadler (Treasurer), John Baugher (Parliamentarian), and Dick Sundt (Co-Chair of the Documentation Committee) on March 9, 2015 to review and purge documents in accordance with the FVCA Records Retention Policy. All documents required to be retained will be moved to Best Fit Solutions for storage, along with all "Vital Documents," whether covered by the retention policy or not, under #3 of said policy.

The items deemed memorabilia are currently being stored at the Sundt home. Maurice Stadler will store the holiday decorations at his home. There is an old gas lantern that was previously on one of the entrances and is missing the globe. Any resident is welcome to have this item, otherwise it will be discarded.

FVCA plans to vacate the storage unit where documents and holiday decorations are currently being stored in April. This will result in an annual savings of approximately \$900/year for the subdivision.

- C. Tim Mattingly provided an update on the Memorial Traffic Study. The committee formed to review neighborhood traffic does not have authority to add stop lights or stop signs. The traffic department is able to add restrictors and/or one way streets to slow down traffic. Please contact Tim with any suggestions to better traffic flow in Fonn Villas.
- D. Joe Bono provided an update concerning outsourcing review of architectural plans. HBL Architects will review plans for compliance with FV architectural standards for approximately \$200 per plan. Joe suggests requiring a \$2500-5000 deposit from builders of new construction to cover this and any other fees incurred by Fonn Villas during the construction process (with any balance remaining at conclusion of construction refunded). Joe will request that HBL present proposal at next monthly meeting. Paul Dunne suggested review and revision of the architectural standards.
- E. Jim Egger moved that the Board approve the 2015 Annual Assessment for the Community Facilities. Paul Dunne seconded. The motion was approved unanimously.
- F. Jim Egger moved to accept the resolution from Best Fit Solutions for the Alliance Association bank account. Karl Holub seconded. The motion was approved unanimously.
- G. Jim Egger moved to add the following to the FVCA Planning Calendar: "February-March: Approve the minutes of the latest organizational meeting of the Board." Paul Dunne seconded the motion. The motion was approved unanimously.

- H. Jim Egger requested suggestions of individuals or organizations that might be willing to maintain the Attingham hedge, the wall on Town & Country Way, and other areas bordering the subdivision, as FVCA cannot maintain these areas. Makeea Grainger has been told that the City will only mow these areas once per year. She will try to persuade a local business to take an interest in maintaining these areas.
- I. Jim Egger moved to elect Pat Clynes to replace John Moyell on the Board and to the position of Security Chair for the neighborhood. Joe Bono seconded the motion. The motion passed with one abstention by Melinda Speight.

### IX. ADJOURN

Jim Egger made a motion to adjourn the meeting. Karl Holub seconded the motion. The motion was approved. The meeting was adjourned at 8:35 pm.

### Minutes of Meeting

### A. Law Enforcement Update - HPD - Officer Kathy Buckler

- Area Crime Statistics covers the 30 day period early Jan to early Feb 2015
  - a. Violent Crime down 50%
  - b. Non-Violent Crime down 10%
- Law Enforcement starting to see a rise in the number of motor vehicle burglary cases. Reminder to be aware of where you park your vehicle and what you keep stored in trunk or back seat.
- With the weather starting to turn warmer and the start of daylight savings time, there
  is a large increase in the number of pedestrians participating in outdoor activities —
  walking, running, bike riding, etc. Caution from HPD about the use of full
  headphones while participating in these activities. Use of full earphones prevents
  runners/walkers from hearing warning from vehicles or other folks using the same
  trail/sidewalk. Be safe.

### B. Houston City Council Update - Dist G City Council Member Oliver Pennington

- Memorial Drive Reconstruction Project looking to award construction contracts in July 2015 with scheduled construction start mid Sept 2015
- Councilman has allocated \$24K for the upgrade of the Bendwood Park tennis courts
- City has allocated expenditure for the replacement of mulch at the Bendwood Park playground area
- Councilman gave a quick overview of major issues being discussed at City Council.
   Number one on the list is the City of Houston budget and the impact of municipal pensions

### C. Guest Speaker – Catherine Butsch – Houston Parks Board (a non-profit) – Bayou Greenways 2020

- Houston Parks Board is NOT a City of Houston organization. It is a non-profit working in Houston.
- Bayou Greenways is the largest project undertaken by Houston Parks Board. It is spending \$220 MM in an effort to create over 150 miles of connecting trails that link the nine (9) major bayous within the City of Houston.
- The money is a combination of Federal grants and private donations.
- Presentation gave an overview of the plans to connect the bayous and the status of the areas that are complete.

### D. President's Report - George Sergesketter

 George gave an overview of the Bills now in the Austin session of the House/Senate that are related to Home Owners' Associations. Of particular note is HB 971. He recommended that all HOAs send letters to their representatives to ensure this Bill is not enacted

### Local Interaction Group Meeting – March 27, 2015

- 2. Citizens there to see draft presentation, offer comments so LAN could fine tune the presentation for the meeting
- 3. Footprint is on Memorial Dr, Beltway 8 east to Tallowood Dr. (4,600 ft)
- 4. No discussion of any work being done on Gessner
- 5. TXDOT project Kirkwood west to Eldridge
- 6. Drainage
  - a. Adding single 10x10 boxes Beltway to West Bough
  - b. Adding double 10x10 boxes West Bough to Tallowood
  - c. Looking for net increase of 10 acre ft
- 7. Mobility & Safety
  - a. Sidewalks on both sides of Memorial (8 ft wide)
  - b. ADA compliant
  - c. Smooth out some of the curves
  - d. Add esplanade along entire area of project
  - e. No current plan for traffic light at Tallowood
  - f. Project will extend past Tallowood to allow for tapering of esplanade
  - g. Some ROW use will cause some commercial and residential changes
    - i. Ex: some of the parking lot in front of Tres Market will most likely be taken
- 8. Things to Keep in Mind
  - a. Esplanade can be anywhere from 20ft, 24ft, or 30ft
  - b. Will have left turn lane near Beltway
  - c. Will have left turn cutouts along Memorial
  - d. If you are concerned COH may try to pull out the esplanades sometime in the future to provide more lanes then you should lobby for the narrower esplanades as you cannot tear these out for more lanes
  - e. However, a narrower esplanade will make left turns using the cutouts more problematic as bigger vehicles cannot enter all the way into the cutout. The rear of the vehicle will "stick out" into the left lane and cause traffic issues.
