Two persons were murdered last week in our general area. At Nottingham Park, a person was killed by three gunshots in an apparent car-jacking. The alleged shooter took off in a 2015 black Nissan Altima 4-door (GSK 5233).

There has been an increase in auto burglaries and 90% have been because owners leave their vehicles unlocked. There has also been an increase in burglaries, robberies and thefts. Also, make sure you are setting your home alarms.

2. Nottingham Drainage and Paving Project (M-000247)

• We will be presented PWE's finding and recommendations to our office early in the new year; we will then work on how to communicate their plan to the public (emails to Nottingham Task Force, eblasts to neighborhoods, another public meeting, meeting with NTF, etc.).

3. Parking Citations:

5. Concrete Panel Replacement Kirkwood has Begun:

- Council Member Greg Travis is pleased to announced that the concrete panel replacement project on Kirkwood Road is finally underway. He utilized nearly \$300,000 of his FY2016 Council District Service Fund (CDSF) for this project.
- The project covers minor roadway repairs in the 11500 block of Riverview and in the 1500 block of Kirkwood Road @ Lakeside Place (removal and replacement of 8"-10" concrete slab, 6" base and 6" curbs).
- Much more substantial concrete panel replacement will be conducted in the 1700-1900 blocks of Kirkwood Road (removal and replacement of 8"-10" slab, 6" base and 6" curb, saw cut in the northbound esplanade and gutter lanes, and replacement of nearly 11,500 cubic feet of concrete).
- The rehabilitations will also include utilization of approximately 2" of lift and stabilization using the Uretek Method, also known as polymer injection, in areas of excessive panel lift, subsidence or separation. This is the first time this new road rehabilitation technique will be used in Houston; it has been successful in several other cities. Just over 3,000 cubic feet of this new material will be injected under the roadway in the range of 1936-2022 Kirkwood Road to bring the separated panels back into grade and alignment.

6. Terry Hershey Park Closed on North Side between Kirkwood and Beltway 8:


- The Harris County Flood Control District (HCFCD) has informed our office that it plans to close Terry Hershey Park from Kirkwood Rd. to Beltway 8 (Sam Houston Tollway) on the north side of Buffalo Bayou, effectively immediately, in order to finalize their emergency repair project.
- Unfortunately, an active construction site within open park space has led to dangerous situations involving pedestrians and bike riders on a daily basis. To minimize these risks moving forward, Terry Hershey Park will be partially closed for the duration of HCFCD's construction project. Other areas of Terry Hershey Park remain open. Specifically, the north side of Buffalo Bayou between Kirkwood Dr. and Highway 6; the entire park on the south side of Buffalo Bayou remains open from Beltway 8 to Highway 6.
- Closure in the repair area is effective immediately and will last until bank stabilization repairs are complete. Harris County Constables will be patrolling the closed area and issuing citations to trespassers. For your own safety, please completely avoid this area of Terry Hershey Park.

7. Removal of Revenue Cap

• Most probably the revenue cap that the voters put in place will be on the ballot for removal on November 7, 2017. Approval would have a negative impact on the ability of TIRZs to fund projects (as they are not subject to the revenue cap). For example, the CIP for Frostwood drainage would not go forward.

IV. Treasurers Report & New Members - Susan Thompson

Susan Thompson, Memorial SN Treasurer, reported that Memorial SN has a bank balance of \$1,673.94 as of the end of November.

Hudson Forest HOA has requested to join Memorial SN and its membership will be voted on at our January 2017 meeting. Delegate is Peter Anderson and Alternate is Connie Voss.

V. Mayor's Citizens' Assistance Office - Rhonda Sauter, Department of Neighborhoods

Rhonda Sauter with the Department of Neighborhoods, Citizens Assistance Office, is available to assist with neighborhood matters. If issues are not being resolved, she can be contacted to provide assistance. Her contact information is on the home page of Memorial SN's website.

She also had available forms for HOAs and civic clubs to update their contact information for the Department of Neighborhoods.

Margaret Dunlop from METRO discussed bus ridership and directed us to look at Metro's website for Super Bowl closures and routes. The Harrisburg overpass will soon be open for the East line.

VI. Memorial Drive Reconstruction (N-000798) - Randy Jones

The contractor progress meeting was held last Wednesday and the goal is to have concrete to Tully by the middle of January. The contractor would like to move to Phase 12 at Turkey Creek and then Phase 13 to the east to work on storm sewer issues. The speed limit in the construction zone is 20 m.p.h. (signs were not posted at the time, but now are). Fines are up to \$150 per mile over the speed limit. The project has reached the 240-day mark, which is roughly 30% of their contract time with approximately 600 days to go. It was noted that an issue has existed with drivers making illegal turns from Memorial

on to Kirkwood and Tully. Traffic reroutes, temporary lanes, signage, and signals are still in constant juggle, but it's something the contractor is working on.

VII. Kirkwood Project - Fran Marintsch & David Mandery (Nottingham Task Force)

Fran and David gave an updated presentation on the project. The project was recently reworked by the

City, but in effect it will take out all the trees in the medians. The Task Force has proposed an alternative plan to have a dual use sidewalk to minimize the loss of trees.

Upon motion duly made and seconded, it was unanimously approved that, "The Memorial Super Neighborhood Council endorses and supports the Nottingham Task Force Plan as the preferred alternative for the reconstruction of Kirkwood as part of the City of Houston CIP M-00247, Nottingham Drainage and Mobility Project." A letter to that effect would be sent to the City (which letter was signed on December 22nd.)



VIII. Infrastructure - Rob Benz

Discussed Kirkwood project south of Buffalo Bayou and noted that Russ Poppe with Harris County Flood Control District had discussed detention related to the Frostwood area. Harris County is completing the tree inventory on Buffalo Bayou noting specimens, marginals and trash. In order for TIRZ 17 to be able to start and complete proposed detention projects, its life would have to be extended to ensure the funding authority to incur and pay off those projects' costs was adequate.

 - (i) in a place located on the association's common property or, with the property owner's consent, on other conspicuously located privately owned property within the subdivision; or
 - (ii) on any Internet website maintained by the association or other Internet media; and
- (B) sending the notice by e-mail to each owner who has registered an e-mail address with the association."
