Approval of minutes – Branch:

Treasurer's report - Teixeira:

- Slightly behind on assessment but not unusual
- \$300 ahead on the budget
- Pool: doing fine

Architectural Standards Committee report – Gleaves:

• Currently 6 new homes under construction in Fonn Villas, and 2 remodelings

• YTD the ASC has approved 2 new pools, 2 whitewashed brick exteriors, 1 new roof, and 1 new covered patio

Security - Ferrier

- Met with Constable good meeting
- Met with Frostwood, suggested changing the schedule of constables 2 during the day and 1 at night because many people don't have anyone home during the day

Community facilities – Hill:

- A lot of damage from the freeze to the pool: \$2K total plumbing bill

- City is looking for a large open space to set up a mobile library

- Report from Super Neighborhood President on new sidewalk and detention regulations:
 - All new construction or remodeling requires including a sidewalk by their house the City is communicating this directly to the builders
 - Any new construction or remodel for lots over 7501 sq ft must have own detention → the system cannot empty out into the street, it has to go directly into a drain system
